Among other items, the Nassau/Suffolk TCC will take an action to functionally reclassify two (2) village roadways – Oak Street and East Lakewood Street – located in the village of Patchogue in Suffolk County. Metropolitan planning organizations are required to take action to approve the functional reclassification of roadways within their jurisdiction. Functional classification is the process by which streets and highways are grouped into classes according to the character of service they are intended to provide.

Hear how pedestrian planners within NYCDOT's Pedestrian Projects Group have tamed traffic at some of the city's most vehicle-dominated locations. Last year the complex puzzle presented by the Hoyt-RFK Bridge interchange in Astoria and the complex traffic patterns at Grand Army Plaza in Brooklyn were made into more rational operations that kept traffic moving while enhancing the pedestrian and bicycle experience. Nagle and Tenth Avenue in Manhattan, Macombs in the Bronx, and Union/12th Street along with Washington Avenue in Brooklyn received pedestrian safety improvements.
